This Privacy Policy details **arvC**'s policies and practices intended to protect the privacy of our members, vendors, and others who use the Site. We recognize the need for appropriate protection of your Personal Information, such as your name, address, telephone number, e-mail address, and other information that you voluntarily share with us online and that identifies you personally, either alone or in combination with other information available to us ("Personal Information"). The purpose of this Privacy Policy is to let you know what Personal Information we may collect from you when you visit the Site, how we use such information, and the choices you have regarding the use of, and your ability to review and correct, and your Personal Information.

The Privacy Policy is incorporated into and subject to the **Terms of Use**, described elsewhere. Information Collection

arvc collects Personal Information from you when you sign up to become a member by completing a membership application either online or in written form that we ask you to provide voluntarily. The information contained within the membership form you complete is used to create your personal member profile and your information will be maintained and stored in a central member database. You can update your Personal Information at any time on **arvc**'s respective online platforms or by calling **arvc** directly.

The above mentioned profiles are separate and unique, and not attached to, a profile created in the **arvc** Community social networking site, also known as the "**arvc** Exchange", which members may voluntarily set up in order to participate. When you register on the **arvc** Exchange, you create your own profile and your own visible privacy settings. When you submit profile information in the **arvc** Exchange, you will be sent a confirmation email that you must respond to in order to complete the registration process. Once you are registered in the **arvc** Exchange, you will be given the option to add Personal Information about you to your profile. By using the privacy settings on your profile in the **arvc** Exchange, you can control which users have access to certain personal profile data. Basic profile data including your username, photo, and current location, cannot be hidden and will always be displayed in the

arvc Exchange once you register. If you choose to set up a social networking profile in the **arvc** Exchange, you will remain a participant until you choose to delete your profile, there is a cause for it to be deleted by **arvc** staff, or your use of the Site is otherwise terminated in accordance with the Terms of Use.

Please note that the **arvc** Community "(**arvc** Exchange)" is powered by Ning. Ning has its own privacy policy that can be found <u>here</u>. In using the **arvc** Exchange, you agree also to abide by the terms and conditions of the Ning Privacy Policy, as well as all other applicable Ning policies and terms of use.

You must be a current member or associate, in good standing, of **arvc** to visit the member area destinations within the Site, and are required to enter a login and password to gain access to this content area.

You can visit the initial and secondary landing pages destinations within the Site anonymously, without providing any Personal Information, passwords or logins. However, when you visit the Site, we automatically collect and log certain non-personal electronic data, such as your Internet Protocol (IP) address and online activity data.

Like most standard website administrators, **arvc** processes information from all visitors to its Site. Information collected may include the browser you are using, the internet address from which you linked to our Site, your unique IP address, usage and browsing habits.

Cookies may be placed on your computer when you visit our Site. Cookies are small data files that include non-Personal Information that can be used to recognize and login repeat visitors to facilitate user access and use of Site content and features. You can instruct your browser not to accept cookies; however if you disable this function and prohibit our collection and use of cookies, it may delay the efficiency with which you may navigate through the Site, or disable some of the use of features, within all our online platforms.

If you choose to utilize online registration functionality within our Site, we ask you to provide certain Personal Information voluntarily. If you choose not to provide the information requested, you may be unable to access or use certain services contained on our Site.

arvc may collect your Personal Information through your use of the Site, including without limitation, through the following actions:

- Your submittal of an application for **arvc** memberships.
- Your submittal of a registration for conferences and educational events
- Your submittal of a registration for sponsorships, exhibit space or advertising insertions.
- Your purchases from the online store.
- Your submittal of a response to ArVC's calls for papers or presenters at conferences and other events.
- Your participation in online discussion forums and blogs and submission of comments and inquiries using online forms, including the Contact Us form and surveys.

arvc does not intentionally or knowingly collect information from children under the age of 13. **arvc** neither identifies information as originating from children nor does **arvc** target its marketing, communications, our online platforms or any goods or services to children.

Information Use

Your Personal Information for our own business and administrative purposes, such as, without limitation, responding to your questions or comments; identifying programs and events that might interest you; managing your membership and online purchases and coordinating volunteer and committee activities. Company name, contact name, address, fax, e-mail address, telephone numbers, affiliations, job title, gender, age and other similar information is used by arvC to respond to member questions and inquiries, understand and communicate member benefits and educational opportunities to members, customers, and site visitors who are likely to be interested in them. arvC does not sell, rent, or otherwise release telephone numbers to any third party, nor does arvC use telephone numbers for any other purpose other than stated above.

arvc provides some Personal Information collected to third party national association members and partners, as part of their benefit package including: name, address and e-mail address. Prior to **arvc** agreeing to provide Personal Information, the third party must provide **arvc** with the exact intended use of the Personal Information and a sample of the mailing piece. **arvc**'s decision to provide Personal Information to a third party is based on the educational/informational nature of the mailing piece, whether it furthers **arvc**'s or its members' overall interests and whether it is consistent with **arvc**'s mission. **arvc** does not provide to third parties telephone numbers or fax numbers.

Information we collect that does not identify you personally is used to monitor the use of and improve our Site, as well as for other internal analysis. In particular, but without limitation, IP addresses are used to diagnose problems with the server on which this information is stored, analyze trends and statistics, site administration, track user movements, gather information about site usage, improve visitors' online experience, and to facilitate navigation within the Site.

In addition, **ArVC** has agreements with various affiliated organizations that promote **ArVC** on the Site. These affiliates may use website analytics to track users. Personal Information is not shared with outside affiliate organizations unless expressly written.

arvc uses third parties to provide certain services for our Site, including administrative support for certain online activities such as, but without limitation, product purchases, payment processing, and event registration. In connection with providing these services, we may share your information with these third parties, and when appropriate, law enforcement authorities. In addition, these third parties may collect certain Personal Information such as your name, address, telephone number, and e-mail address. Although we strive to select only reputable companies that share our commitment to user privacy, we are in no way responsible for the actions or policies of these third parties.

arvc only shares your Personal Information with organizations that work on **arvc**'s behalf. In certain instances we may also disclose your Personal Information when we have reason to believe that it is necessary to identify, contact, or bring legal action against persons or entities that may be causing injury to you, us, or others.

Member and customer credit and debit card information is not stored or maintained by **arvc**. When members and customers choose to pay online using a credit or debit card, that information is processed directly through a third-party clearinghouse using appropriate security processes and data encryption.

Third-Party Links

Our Site contains links to third-party websites that are provided for your convenience. We do not endorse nor are we responsible for the privacy practices or the content of such sites.

Disclosure of Personal Information

When you register on the **arvc** Exchange and create your own social profile, you are able to set up a unique personal profile and create an online network to engage with other online community users. Users can view each other's profiles, communicate, share photos, videos, documents and post commentary and other information. Be aware that by using any of these features, you may make your Personal Information accessible to the respective online community. **arvc** has no control over how those users may use your Personal Information.

Except as otherwise expressly included in this Privacy Policy, this Privacy Policy addresses only the use and disclosure of Personal Information and other information that **arvc** collects from you. Opting Out

Registered users of our Site may access and update their account information at any time. **arvc** recognizes that members and visitors may wish to limit the use of Personal Information, and that this decision may occur after such information is provided to **arvc**, via our online platforms or otherwise. Registered users are provided the opportunity on this Site, and may voluntarily opt-out of having their contact information provided to third parties by **arvc** at any time.
